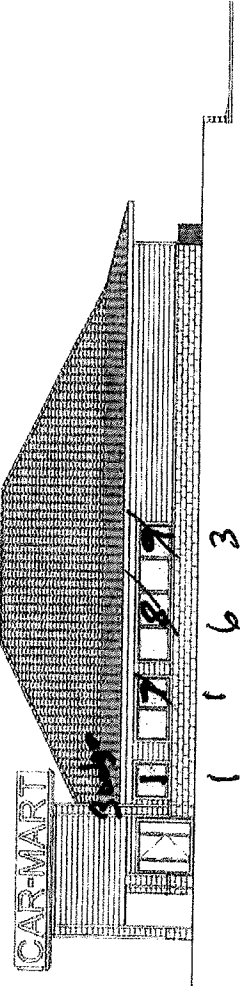
FRONT ELEVATION
