## **GENERAL DESCRIPTION OF POSITION**

Works in a variety of conditions, indoors and outdoors, in various types of weather to maintain the city water system. Other duties may be assigned.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES**

1. Assists in connecting water and sewer lines to mains.
2. Performs operations of equipment such as jackhammers, chop saws, bush hogging equipment.
3. Assists in repairing broken wastewater lines, and replacing worn and damaged parts of the wastewater system.
4. Assists in repairing breaks in water.
5. Performs checks on all pump stations, and assists maintenance of pump stations.
6. Use of basic and specialized hand tools.
7. May act as temporary relief for other departments as needed.
8. Performs daily logs and reports as assigned.
9. Regular and punctual attendance.
10. Ability to interact with team members.
11. Ability to work overtime.
12. Perform any other related duties as required or assigned.

## **QUALIFICATIONS**

To perform this job successfully, an individual must be able to perform each essential duty mentioned satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required.

## **EDUCATION AND EXPERIENCE**

Mental alertness and adaptability to office and field area work routines. Equivalent to four years high school, with particular emphasis during high school in office skills, shop skills, or others, plus 0 to 6 months related experience or training. Or equivalent combination of education and experience.

## **COMMUNICATION SKILLS**

Ability to read and understand documents such as policy manuals, safety rules, operating and maintenance instructions, and procedure manuals; Ability to write routine reports and correspondence.

## **MATHEMATICAL SKILLS**

Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent and to prepare and interpret bar graphs.

## **CRITICAL THINKING SKILLS**

Ability to utilize common sense understanding in order to carry out written, oral or diagrammed instructions. Ability to deal with problems involving several known variables in situations of a routine nature.

## **SUPERVISION RECEIVED**

Moderately repetitive. Activities with slight variation using a definite set of processes or directions with some degree of supervision. Choice of learned things in situations which conform to clearly established patterns and modes.

Regular use of complex machines and equipment (desktop/laptop computer and software, road and production machines and equipment, etc.)

## **ACCURACY**

## **PHYSICAL ACTIVITIES**

While performing the functions of this job, the employee is regularly exposed to outdoor weather conditions; occasionally exposed to work near moving mechanical parts, work in high, precarious places, fumes or airborne particles, toxic or caustic chemicals, wet or humid conditions, extreme cold, extreme heat, risk of electrical shock. The noise level in the work environment is usually loud.
