GENERAL DESCRIPTION OF POSITION

Works in a variety of conditions, indoors and outdoors, in various types of weather to maintain the city water system. Other duties may be assigned.

ESSENTIAL DUTIES AND RESPONSIBILITIES

1. Assists in connecting water and sewer lines to mains.

- 2. Performs operations of equipment such as jackhammers, chop saws, bush hogging equipment.
- 3. Assists in repairing broken wastewater lines, and replacing worn and damaged parts of the wastewater system.
- 4. Assists in repairing breaks in water.
- 5. Performs checks on all pump stations, and assists maintenance of pump stations.
- 6. Use of basic and specialized hand tools.
- 7. May act as temporary relief for other departments as needed.
- 8. Performs daily logs and reports as assigned.
- 9. Regular and punctual attendance.
- 10. Ability to interact with team members.
- 11. Ability to work overtime.
- 12. Perform any other related duties as required or assigned.

QUALIFICATIONS
