HOME PRODUCE SALES, FOWL, BEES & GOATS



Background

The City of Fayetteville passed the Urban Agriculture Ordinance in March of 2014. This ordinance is an update and replacement of the previous "Animals & Fowl" ordinance and includes provisions for the keeping of fowl, bees, and goats, and allows for limited sales of home produced products in residential areas. Under this ordinance, fowl, bees and goats may be kept on lots that meet the requirements in the chart below.

In side or rear yard. 50' from neighboring residence.	200 sf of secure fenced yard per animal	Shall have RFID microchips & be registered with the Fayetteville Animal Services Program. No onsite slaughter permitted.
Bees	No Africanized Bees	2 hives allowed on any lot. For lots larger than 5000 sq ft, 1 additional hive is permitted for each 2500 sq ft of lot area up to a maximum of 4 hives.	Single Family Residential use/ Educational use	In side or rear yard.	In side or rear yard. 20' from property line if fenced. 100' from property line if not fenced.	—	Bees must be registered through the Arkansas State Plant Board & follow all AR. apiary laws. Access to water must be provided.

Sales of Home Produced Agricultural Products

- Home Produce Stand (included under garage sales): No permit required. Home produced agricultural products can be sold 4 times per year, with sales not to exceed 3 consecutive days in duration.
- Home Occupation Permit: Planning Commission approval required. Home produced agricultural products can be sold in all residential zoning districts. Restrictions include hours, operation size and no employees other than occupants permitted.
- Limited Business Permit: Planning Commission approval required. Home produced agricultural products can be sold in all residential zoning districts except: R-A, RSF .5, RSF 1, RSF 2. This permit offers fewer restrictions than a Home Occupation.
