

City of Bryant 4th Quarter Reports 2015

PUBLIC WORKS FOURTH QUARTER REPORT

Projects:

Echo Lake Boulevard - Bids for the Echo Lake Sprinkler were opened on November 30, 2015. Two bids were received; HT Landscaping L.L.C. and Little Rock Landscape, Inc.. The low bid was from HT Landscaping, L.L.C.. A preconstruction conference was held with H.T. Landscaping on December 7, 2015. Work is scheduled to begin on January 4 and be complete by February 4, 2016.

12"Sewer Force Main - The bore under I 30 is complete and contractors are laying pipe between Pump Stations 5 and 25. Work will begin on the pump station upgrades in the near future.

Jump Start Initiative - Reynold's Road Improvements - The October 23 Pop-Up Event on Reynolds Road on October 23 to simulate how proposed improvements may look was a success in spite of the rain.

Raymar On and Off Ramps - A Resolution expressing Bryant's willingness to partner with AHTD and authorizing Mayor to execute agreements is was adopted by City Council on October 27. The City has committed \$200,000 toward the project.

Master Plan for Pedestrian and Bicycle Paths, Trails and Streets - Garver is still working on the draft plan..

Sludge Removal and Disposal Project - Work has begun to haul sludge away from the Wastewater Treatment Plant. This project, in preparation for installation of dewatering equipment, will use the last of the Arkansas Natural Resources Clean Water Revolving Loan funds.

Dewatering Project - Bids for equipment were opened on December 10. Two bids were submitted; Andritz and Instrument and Supply. Instrument and Supply submitted the low bid. The engineer and City staff are in the process of comparing the details of the two bids before a final decision is made.

Boone Road Water Line Replacement Project - Bids are scheduled for opening on December 15, 2015.

Street Department

Street crews continue to make new street name signs as time permits. We are having to replace a lot of stop signs with the new high intensity ones.

Some areas on Springhill Road had to be repaired after the widening, such as sidewalks to houses, flower gardens, mail boxes etc. This has been completed. Potholes are a never ending job from summer through winter. The on Raymar Road have been extended and it has been overlayed. Striping should be completed before year end

A new traffic/crosswalk bridge at Bishop Park was completed to help with foot traffic at the park. New sidewalks have been extended in the Pleasant Point Subdivision, so school children can walk across Wilkerson Rd to Pleasant Point and onto the school at Hill Farm.

Crews are making sure the City is prepared for the upcoming winter, making sure all salt spreaders are working, and stockpiles of both sand and salt are ready. The Street Department is putting together a salt brine system that could prove helpfulwhen it is sprayed on the roads to prevent icing of bridges and trouble spots when winter hits.

Leaves are always a problem in the fall and late winter. Crews will continue with the street sweeping as much as possible and when weather permits. Cleaning out culverts is always an issue this time of year.

Inspections: Commercial & Construction

 Kids Academy, Civitan, Harper's Crossing, Hunters Crossing, Andreas Gardens, City Sewer Expansion, Oak Glen Phase III, Crain Drive, Andreas Place, Todd Lane, Dollar Tree, Regan Brown on Walnut St.

Inspections City Municipal:

• Have done three separate City facility inspections at Streets, Water, Wastewater and Parks including training and corrective action. Also took water samples at each of these facilities during rain events to test for turbidity. Overall things looked good.

Inspections: Post Construction (basins), Dry Weather Screening (illicit discharge) and Outfalls.

• Spent the best part of October performing MS4 permit required inspections of all the Stormwater Outfalls from the City, post construction privately owned detention basins, and other waterways for signs of illicit discharge. Inspections were documented and journaled with photographs.

Training: Internal, municipal and public

- Dion and I attended the 4 day, EPA Region 6 Stormwater training conference in Hot Springs. We picked up many great ideas & knowledge. One idea was the creation of our own character named Stormwater ED which we have turned into a cartoon strip for Public Outreach on Best Management Practices. Ed has appeared in two City newsletters so far and has helped bring awareness to pollution and proper functioning of stormwater inlets.
- We also hired a new person in our department named Jay Stake. He has hit the ground running
 and is doing a great job. He has been receiving on the job training as well as through text &
 video.

- During facility inspections and the event Pop Up Reynolds, we have also trained several City employees in Streets, Fire, Police and Parks on Stormwater Pollution Prevention.
- Dion has also held Tailgate Training sessions with contractors, landscape companies, commercial businesses and trash service companies on site on BMPs.
- Maintained the City Monthly Newsletter and reached the public with Environmental messages.

Special Projects: Clean Up and other events

- We assisted Parks Department at Bishop for four days with prison labor giving direction and supervision over the clean up of the grounds, as well as in and along the creek to help improve the appearance and drainage of stormwater throughout park. Four large dams of debris was removed and discarded from creek bed, underbrush removed and several bags of trash were removed.
- We helped with the setup and tear down of items and equipment for Pop Up Reynolds. I also worked the event providing training and outreach on stormwater pollution prevention information.
- Attended Community Meetings representing Stormwater interests.
- Worked prisoners in maintenance and general clean up in these areas: Forest Cove (entire stretch); City basins on Prickett Road, Ozark Drive, Dollar Tree, West Pointe; small basin in Stoneybrook; City properties at Debswood Bridge, Shobe & Raymar and Streets Department grounds; Meadowlake Subdivision around drainage inlets
- Helped with the Memorial Library/Terri Ellis Project along with Leon Black.
- Cleaned and removed blockage in stormwater drainage pipes in Meadowlake Subdivision from Kellybrook Circle down to Waterford Drive. There was build up of major debris from yard waste.
- Prevented flooding of apartments on Wesleyan Drive by removing blockage in drains during heavy rain event.

SSO's during the fourth quarter, totaled 22 for the year with five sso's in November were during two flooding events in that month. Crews responded to 11 emergency calls, one of which was an emergency SSO call. Crews are working diligently to locate the source of the I&I and make repairs. Wastewater has 14 active construction projects in various stages of completion. Five more are still pending.

Plant Operation

Plant operations during the fourth quarter started slow and have kicked into high gear quickly. Dry weather during the summer months had us operating with low inflow and plenty of storage for the upcoming wet period. That did not last long, in mid November we received several inches of rain and increased inflow. The facilities 1MGD process was brought back online and the EQ basin storing inflow during an 8.35" rain event over the Thanksgiving holiday. For the first week of December the facility treated efflunt flow in excess of 4MGD. All operations are normal at this time and flow seems to be determined by weather period.

Contractors with Denali Water Solutions are working onsite hauling sludge from the storage lagoon. They are also being controlled by the weather but anticipate being finished cleaning the lagoon by end December or early January.

Finance Department 4th Qtr Report 2015

The fourth quarter of 2015 has gone well for the Finance Department. We had a big WIN! Legislative Audit completed the Report for both 2013 & 2014! There were several criticisms in the report but we are addressing these currently. The Enterprise Auditor (Water.WW) is still examining 2013. And the new Auditor Firm, JWCK, was hired and has started the testing for both 2014 and 2015 already.

The Finance Department continues to explore our refinancing options with the intention that upon completion of the audits the city can, and will, move forward swiftly.

The Finance Department also continues to work on several items with Springbrook including but not limited to: Fixed Asset Module Use, Accounts Receivable Module Use, Bank Reconciliation Module Issues, GASB 54 Issues, 1099s, HR using ESS, etc. And the Finance Department hosted several First Time Training Sessions on Springbrook with the different departments in the 4th quarter.

The Finance Department requested of Council at the October meeting the authorization to contract with JWCK and at the November meeting reported the results of the 2013/2014 Leg Audit as stated above. A Special Budget Work Shop was hosted with Council and the Department Heads on the night of the 10th of November and the Finance Department plans to request Council to Adopt the 2016 Budget at the December meeting on the 22nd.

2015 has been the Finance Director's first full year and she has enjoyed it and is looking forward to 2016! Thanks.

Human Resources 4th Qtr Report 2015

- New Human Resources Director, Charlotte Rue, hired on October 6, 2015.
- The Human Resources Department held our annual benefit fair with an effort to highlight overall employee wellness.

Police Department 4th Qtr Report

Police Department has had a busy 3rd and 4th quarter with many changes that will take effect throughout the year of 2016.

Police Dept got approved to purchase a new CAD Software and Reporting Software that will carry us well into the future. This software will assist in solving crimes with some of the advance features that we did not have including analytical, priority dispatch by location and personnel management to track training as well as inventory.




Breakdown of Animal Control Incidents - 4rd Quarter 2015

Legal Department 4th Qtr Report

Pending litigation:

2013- Collins v. COB 2 -Summary Judgment motion denied. Working to include repair costs in 2016 budget of 50k as an offer to fix the ditch and prepare an offer of judgment within the case to limit exposure to damages.

2013 Atkins v. COB - Case Settled.

2015 Bivens v. CoB filed in Federal District Court. Retained ARML to defend and entered an appearance. Plaintiff initially sought to fast track the case, do to discovery and responses to complaint and counterclaim for nuisance abatement the case is slowed down. Discovery responses are completed. Case has a trial date in 2017.

Condemnation cases:

Took City's appraiser's deposition for the Brown property and have scheduled the Grinstead property for December 1. Deposition of Defendant's appraiser went well. Working on gathering FOIA information from Cabot and North Little Rock regarding him. Defendant has also retained a second expert regarding damages to the Brown Property. Both cases are set for trial in early 2016.

Working with McCain Lodging on resolving condemnation case and Alcoa Access issues with Bank of the Ozarks.

Potential Litigation matters:

Resolved Burkhalter overpayment before completion of Legislative Audit report. Full amount paid back to the City. Received over 90,000 owed to the City.

Windstream Franchise Fee issue. Worked with Windstream to identify actual companies that are providing services in City, drafted Ordinance to reflect that and reached agreement on terms. Long process but with persistence the City will recover the franchise fees it is owed and will have a working plan going forward for regular payment. Received payment of approximately 54,000 for back fees owed.

Administrative matters:

Personnel issues addressed. Acted as part HR Director for the period until we hired new HR Director.

Working with landowners along Alcoa for access resolution with Benton and MetroPlan.

Reviewed numerous contracts for different departments, assisted and drafted numerous Ordinances and Resolutions for Council consideration and adoption.

Working with Water Billing on proposal to contract printing, folding, and mailing of monthly water bills to remove the menial burden from City Staff.

Working with Parks department on finalizing fencing issues from the Hall Case.

Working to develop and hire an engineer for flood mitigation at Bishop Park. Budgetary constraints exist.


