PUBLIC WORKS THIRD QUARTER REPORT

Directors Report

Projects:

Echo Lake Boulevard - Design for sprinkler system is done. We anticipate completing that in the nest quarter and the first guarter of 2016

Overlay Springhill Road Widening and Overlay Project - Completed and under budget. Remaining funds are being transferred to work on Raymar.

12"Sewer Force Main - Bids came in under estimates. Work began in August. The bore under I 30 is complete and contractors are laying pipe between Pump Stations 5 and 25.

Jump Start Initiative - Reynold's Road Improvements - The Street Department submitted drawings and a request for a permit to set up a Pop-Up Event on Reynolds Road on October 23 to simulate how proposed improvements may look. The temporary permit has been granted. Street crews will work all night starting October 22 to place temporary signage and stripping for the Friday event.

Raymar On and Off Ramps - The Highway Department has notified Bryant of it's willingness to partner with Bryant for on and off ramps at the Raymar Exchange on Interstate 30. A Resolution expressing Bryant's willingness to partner with AHTD and authorizing Mayor to execute agreements is going before Council on October 27.

Master Plan for Pedestrian and Bicycle Paths, Trails and Streets - Garver is still working on the draft plan..

Sludge Removal and Disposal Project - Winning bid of \$292,252 came in under the \$375,000 estimate. Work to begin this month subject to approval by Arkansas Natural Resources.

Dewatering Project - Bids for equipment are being prepared by engineers. We hope to have the bid out in the 4th quarter.

Boone Road Water Line Replacement Project - Ready for bidding as soon as ADH approves plans.

STREET DEPARTMENT

Mowing season is coming to an end, but it was non-stop for the last three months. The Springhill Road project has been completed and hundreds of people are taking advantage of the left hand turns we were able to put in at Northlake and at Springhill Elementary School. Most of the work to prepare for the widening was building up the shoulders, ditching, asphalt work and putting in several culverts. With the traffic to contend with this project was very time consuming. I would like to thank everyone involved for their help. And a special thank you to Chief Kizer on the occasional issues that required his Department's assistance. We continue to make new street signs when time permits. The new Street Sweeper has been working great. And as soon as we clean up some of the worse areas in the City, we will be on a weekly schedule sweeping in a different Ward each week. We have also been using the Asphalt Patch Truck on a weekly basis; because of the hot weather a lot of larger than usual failures in the asphalt has occured.

MS4 - Stormwater

In the first month of quarter, July, most of our field attention was focused on helping the Street Department with the time sensitive project of repaving Springhill Road on the NW part of Bryant. Dion McGuire and Joseph Davis helped crews with safety flagging. We also removed some problematic trees on City owned property near the Cherry Creek and Lexington subdivisions.

Our Department also began work on the Bryant Sustainable Stormwater Management Program BSSMP. This involved research on proper techniques and methods of using goat and sheep tribes to manage vegetation in detention ponds in a sustainable, safe and cost effective way. We found a service in Fayetteville Arkansas that was doing this successfully and that was a big help. We also researched and found a local farm supply source for the tribe. Our supplier did this on a voluntary, test basis for six weeks to see how it would work. There was no charge for the tribe services. The only expenses were supplies, tools, fencing and feed. The most time consuming tasks involved researching, locating, purchasing and installing all of the fencing, barriers, shelters and equipment around the detention area.

Except for a small percentage of people, the pilot program was widely accepted and a huge success in the neighborhood of Stoneybrook where it was launched. The largest payoff was the way in which it connected people in the community. People came out to watch the tribe and they got to know each other. We had several neighbor volunteers that helped care for the tribe and many new friendships were made amongst neighbors who had never had an opportunity to visit. In the afternoon, people and children alike would stop on the hill to watch the tribe eat. People sent in photos and letters of thanks to me and the City for bringing

the program to their neighborhood. It was a lot of work implementing and managing the program, but very rewarding to see the several positive, personal connections a few goats could generate.

Other projects that I worked on included: researching and writing the Stormwater Management Fund and the Stormwater Management Utility Fee; researched and wrote two entries for Cities of Distinction on Technology Advancement & Tourism (the Technology Piece won first place); researched and wrote a grant for Greening the entrance of Bishop Park with trees and rain garden vegetation to filter stormwater; and lastly, I managed the production of the monthly City Newsletter.

Water Distribution

Projects	 The new Holiday Inn project is moving along. Ray Lusk Plumbing is running the plumbing from the Alcoa Road area to the building. Inspections are looking good at this point. As of 10/8/2015 they are not finished. They will be laying sewer under Alcoa Rd soon. Hunter's Crossing Subdivision on Hwy 5 is complete. Water lines were tested and passed. and as builts are complete. Echo Lake lighting job has been turned over to entergy. The Oak Glen subdivision phase 3 is complete. The lines have been tested and passed as of 10/8/2015 oak glen 4th phase is being installed and we are inspecting daily, we should be testing any day. Hadden Creek Subdivision on Boone Road is under Construction and looking good, inspections are looking good, there about 2 weeks from completion of water and sewer lines. Then we will test and bacteriologica sample. We have been locating water lines with the Vaccon for the 16 inch sewer force main along Raymar Rd We are working with the airport to move a water main and hydrant for the fire department so they can hook up fire planes quicker and easier. We made two repairs at the booster station on the Chlorination system to insure that we dispense chlorine correctly, (replaced two check valves).

Wastewater Collection

Wastewater crews completed 170 work orders in the third quarter. Seven SSO's were reported to ADEQ. SSO's last year, the end of the third quarter, totaled 19. The third quarter total for 2015 is 14. Crews smoke tested 33,700 feet of sewer lines in Basin 5. Of the 13 defects that allow Inflow and Infiltration, 12 have been repaired and 1 is scheduled for repair. Wastewater crews repsonded to 11 emergency calls for possible main blockages. Three SSOs were caused by main blockages. Wastewater has 14 active construction projects in various stages of completion. Five are pending.

Plant Operation

Plant operations during the third quarter have been routine. Dry weather has attributed to low flow into the treatment facility. In early July we closed down the 1 MGD process to help maintain a healthy microbial population in the 2 MGD process. In August.

ADEQ paid a visit for an annual inspection of the treatment facility and the stormwater permit. Concerns about an area at the Street Depts. fuel tank was the only issue listed in the stormwater report. These concerns were addressed and the Dept. has decided to move the fuel tank and build a containment area.

An issue noted as a violation on the treatment facility inspection for vegetation present in the sludge storage lagoon was cleared up when we presented documentation of our plans to have the lagoon cleaned. Being proactive in our plans to clean the lagoon had us ahead in our response to ADEQ's request. Both responses to these reports were submitted to the Inspection Division. The project to clean the sludge storage lagoon was awarded to Denali Water Solutions. They will be working onsite for the next couple of months removing sludge and hauling it to an area they have permitted for land application.

The treatment operators are excited to welcome new operator Michael Palacios to the team. I have been working with him instructing on the flow process and the duties of a treatment operator. He will be attending required courses later in October to obtain certification.

Colder weather is just around the corner and we anticipate higher flow volumes during the wet season. All equipment is ready to go online to handle any increased inflow to the facility.

However the Finance Department did put out an RFP for Auditor Services for Enterprise for 2014 and Governmental for 2015 and we hope to take the committee's recommendation to Council October 27.

The Finance Department continues to explore our refinancing options with the intention that upon completion of the audits the city can, and will, move forward swiftly.

The Finance Department also continues to work on several items with Springbrook including but not limited to: Fixed Asset Module Use, Accounts Receivable Module Use, Bank Reconciliation Module Issues, GASB 54 Issues, 1099s, HR using ESS, etc. The Migration in Springbrook from platform 7.15 to 7.17 was completed successfully in the 3rd quarter as well as moving from manual signature approval to electronic approval of POs in Springbrook. .

Two members of the Finance Department represented Bryant at the Arkansas Government Finance Officers Association Annual Conference during the 3rd quarter. It was a very good conference and many items were learned from attending.

The Finance Department requested of Council at a Special Meeting in July the authorization to contact ADHD regarding the on and off ramps at Raymar South. The Levy of Real and Personal Tax was brought before Council at the regular July meeting, and the movement of the old Firemen's Pension Plan to LOPFI was proposed and approved at the August meeting. All in all it was a busy summer quarter.




Breakdown of Animal Control Incidents - 3rd Quarter 2015

Legal Department 3rd Qtr Report

Pending litigation:

2013- Collins v. COB 2 -Summary Judgment motion denied. Working to include repair costs in 2016 budget of 50k as an offer to fix the ditch and prepare an offer of judgment within the case to limit exposure to damages.

2013 Atkins v. COB - Case Settled.

2015 Bivens v. CoB filed in Federal District Court. Retained ARML to defend and entered an appearance. Plaintiff initially sought to fast track the case, do to discovery and responses to complaint and counterclaim for nuisance abatement the case is slowed down. We are presently working on responding to discovery as well as waiting on Plaintiff to respond to discovery we submitted to them.

Condemnation cases:

Took City's appraiser's deposition for the Brown property and have scheduled the Grinstead property for December 1. I am scheduled to take their expert's deposition Monday Nov. 23 in both Brown and Grinstead. Both cases are set for trial in early 2016.

Potential Litigation matters:

Resolved Burkhalter overpayment before completion of Legislative Audit report. Full amount paid back to the City.

Windstream Franchise Fee issue. Worked with Windstream to identify actual companies that are providing services in City, drafted Ordinance to reflect that and reached agreement on terms. Long process but with persistence the City will recover the franchise fees it is owed and will have a working plan going forward for regular payment.

Administrative matters:

Personnel issues addressed. Acted as part HR Director for the period until we hired new HR Director. Working with landowners along Alcoa for access resolution with Benton and MetroPlan.

Reviewed numerous contracts for different departments, assisted and drafted numerous Ordinances and Resolutions for Council consideration and adoption.

Freedom of Information Act Requests:

Responded to and reviewed numerous FOIA requests from the public, media and other city officials.


