No bidder may withdraw his bid within 60 calendar days after the actual date of the opening thereof. The Owner reserves the right to waive any informalities in the bidding and to reject any and all bids.

All Bidders must be licensed in accordance with the requirements of the Arkansas Contractors Licensing Board in accordance with Act 150 of 1965, as amended. All bidders must be qualified in all respects to do business in Arkansas.
