2. Parks Committee Recommendation

The Bryant Parks & Recreation Committee recommends the City Council amend the A&P Special Election Ordinance to designate 70% to parks, 25% to the A&P Commission, and 5% to administrative costs. Anything less than 70% with the 3.0 millage rate currently under consideration by the Council will effectively result in a dramatic reduction in the parks' current budget of \$3.7 million. In fact, the ordinance as amended at the last Council meeting allocating only 30% to parks would be a twenty-five percent reduction from our current budget. That would be a major step backward and force parks to operate at a subsistence level with no growth, no added services, and deferral of essential maintenance. In addition, with the 30% level of designated funds from the A&P, the parks' strategic planning process authorized by the council will become a wasted effort and a waste of \$50,000 of taxpayer money paid to consultants facilitating the development of the plan. More importantly, it will be a breach of faith with the 44 people representing a broad and diverse cross section of the community serving on the planning committee for more than 18 months, and the more than 1,000 people responding to our survey seeking their input into how they would like to see their parks system grow and develop.
