In addition to the annual permit fees there is a city tax of 10 percent (10%) upon the gross proceeds due monthly. Wine and beer containing less than 5% alcohol shall not be subject to the supplemental tax.

Retail Liquor Off-Premises Permit

Renewal Cost: \$425.00

Retail Beer and Light Wine Off-Premises Permit

Retail Beer and Light Wine On-Premises Permit

For a retailer whose annual gross sales of beer and/or light wine do not exceed \$1,000.00, the permit fee shall be \$15.00. For a retailer whose annual gross sales of beer and/or light wine do not exceed \$2,000.00, the permit fee shall be \$20.00. For retailer whose annual gross sales of beer and/or light wine exceed \$2,000.00, the permit fee shall be \$20.00 plus an additional \$5.00 for each one thousand dollars (\$1,000.00) of gross annual sales in excess of \$2,000.00. The permit fee for a new application with no sales history shall be \$40.00

Wholesale Beer and Light Wine Permit

Annual permit fee of \$125.00 for each and every wholesale dealer, broker or distributor of beer and light wine or malt liquor.

Renewal Cost \$125.00

Beer Manufacturing Permit

Renewal Cost \$250.00
